summary: This paper proposes changes to the Bye-laws and regulations relating to membership:

- There are no significant changes for UK qualified members
- The changes would put beyond doubt the eligibility of HCPC registered physiotherapists who qualified overseas
- A change would make it explicit that Student members are not eligible for union services or to take part in trade union ballots
- It is proposed to create a career break grade for Associates
- A revised definition of the duties undertaken by members qualifying for associate membership is proposed
- Council is invited to consider clarifying Associate voting at the AGM
- It proposed to make provision for the future admission as an Associate member on the basis of a non-graduate qualification
- It is proposed to repurpose the Affiliate category of membership and use this for a range of different groups of people with a professional interest in physiotherapy who are not eligible in any other category.

1. Introduction

- 1.1 The context in which the Society works is rapidly changing as external factors reshape the profession and the context in which we work. These include:
 - Changes in physiotherapy training with mean more multidisciplinary education, the development of degree level apprenticeships and new qualifications for associates being developed.
 - The changing shape of the workforce with fewer specialist physiotherapy managers, the growth of the overseas-qualified workforce and increasing use of other professionals to undertake physiotherapy related roles.
 - The growth of physiotherapy outside traditional settings and contexts including in social care and the growth of animal physiotherapy
 - Changing requirements of trade union legislation.
- 1.2 These factors present the CSP with some fundamental choices. Do we wish to develop our membership to reflect these changes or retain our current model? Both options have risks and benefits. Not adapting could result in the organisation becoming less relevant, membership stalling and a gradual decline. Change too much and too quickly and we could risk our coherence as a professional community. We have therefore presented Council with a set of choices rather than a single block recommendation for change.
- 1.3 The papers of the SLWG have previously been circulated to members of Council. This report therefore focuses on the recommendations made by the SLWG and does not rehearse the evidence and issues considered by the SLWG.
- 1.4 Council established the review in March 2016. The members of the SLWG were Philip Hulse, Sue England and Debbie Davies advised by Rob Yeldham and Stuart du Boos. The terms of reference are attached as Annex A. The group met on five occasions and reviewed all existing categories of membership and potential categories. One session used an external membership consultant to help us develop our thinking through a workshop session.
- 1.5 It is important for Council to bear in mind that no market testing has taken place of these proposals. Staff have advised that until there is clarity about Council's intention testing would not be practical. Some informal consultation has taken place with networks and committees and the outcome of this will be fed back verbally.
- 1.6 We endorsed the "buffet" principle that membership should be the gateway to a range of services and benefits and therefore rejected a move to a form of membership where individuals opt in and out of differently priced services. This reflects both the financial challenges of an "a la carte" membership system and our belief that membership should be about joining the community of members not buying services.
- 1.7 We found that our existing structure contains a range of anomalies. These we have either determined as not significant or have sought to address in the recommendations. It should be noted that there is a risk that unless we clarify entitlements and eligibilities we may find we are judged to be breaching our own Bye-laws and regulations if someone chooses to challenge current interpretations.

1.8 In considering this report it may help Council to understand the distinction between categories and grades of membership:

Categories are the broad classes of membership established in the Bye-Laws of the Society. Categories can only be changed or created by changing the Bye-Laws. This requires Privy Council and AGM consent.

Grades are the administrative designations given to specific groups of members within a category. Grades may be needed to distinguish between different eligibility rules, different subscription rates or to help define access to specific CSP services. Grades and their associated criteria or discounts may be, but do not have to be, based on regulations made by Council.

1.9 If Council, the Privy Council and AGM agreed all the recommendations the old and new membership structures would be:

1.10 Since the Membership Review began, Council has also considered the Governance Review. This has implications for membership regulations relating to Council elections. The proposed governance changes have been factored into the draft amendments in the annexes. Sections in square brackets would only be applied if governance changes proposed are not adopted.

2. Members

2.1 Under our Bye-Laws we have both members (those people who are admitted to membership in any of the categories) and Members (graduate or equivalent level physiotherapist members). Members may be admitted by Council as Fellows. In terms of rights and responsibilities, Fellows are in practice no different from Members.

- 2.2 We have long admitted into Membership HCPC registered physiotherapists who qualified overseas. Their HCPC registration serves as a guarantor of their professionalism. However, one interpretation of the byelaws is that this is not appropriate. To clarify this, it is proposed to amend the byelaws to put eligibility for membership beyond doubt. This would also future proof us if non-CSP accredited routes to HCPC registration are approved in future.
- 2.3 Where Members are solely practising on animals, they are exempt from the requirement to be HCPC registered. For operational convenience, we propose that there should be a separate grade within the Membership category to accommodate them. This would currently involve around 30 Members.

3. Student members

- 3.1 We concluded that the student membership category is effective at providing a suitable membership category and encouraging HEIs to accredit courses via the CSP. We do not believe it should be broadened to accommodate physiotherapy students studying overseas, potential students, students on non-accredited courses, or graduates pending HCPC registration. We believe these groups are better served by inclusion in the proposed affiliate category.
- 3.2 Student members are not legally employees or workers. They have never been regarded as being eligible for union services and have never been given rights relating to the union activities of the CSP. Given trade union regulation change, making this explicit in the regulations is desirable for audit purposes. We therefore recommend amending the regulations to reflect this.
- 3.3 We strongly believe that the existing practice of ending CSP membership on graduation and forcing graduates to reapply for membership as Members is counterproductive. We therefore recommend that we end this practice and allow student members to move automatically into the proposed affiliate category at the point of assumed graduation, pending their registration with the HCPC and eligibility for Membership.

3.4 Risk and benefits

- 3.5 We have included in the proposed revised regulations provisions that make explicit the voting rights of students at the AGM. Currently, as written, students are entitled to vote on all matters at the AGM.

4. Associate members

- 4.1 We concluded that the Associate category should be retained as a distinct category. It accommodates a wide range of different roles many of which are likely to expand in future. This category includes: apprentices, physiotherapy assistants, technical instructor, rehabilitation assistants, overseas qualified physiotherapists undertaking periods of adaptation, qualified physiotherapists undertaking supervised return to practice and other physiotherapy staff. What these groups have in common is that they are people practising physiotherapy, but not as autonomous practitioners. We do not feel that it would be appropriate to extend the category to accommodate a range of potential members who are not directly providing physiotherapy.
- 4.2 We believe that this category continues to be the right one for apprentices, including those on a route to qualification equivalent to graduate level. This is because apprentices, unlike students, are legally employees working in a supervised context. They need, for trade union audit and balloting purposes, to be in a category for employees. As is already the case for members working in physiotherapy roles whilst studying can be in a grade which enables them to access student as well as associate benefits.
- 4.3 In reviewing the existing regulations we noted the need to amend the regulations in two respects:
- (a) To confirm the rights of Associate members in relation to trade union ballots and for certain other CSP activities.
 - (b) To update the definition of delegation to recognise the changing nature of management arrangements within physiotherapy services and to recognise that delegation does not imply direct supervision.
- 4.4 We also became aware of an anomaly which Council needs to consider. It is a perception held by some members that the Bye-Laws prevent Associates voting on clinical issues at the AGM. This is not, in fact, written into the Bye-Laws. We have therefore included a recommendation which enables Council to clarify arrangements through a new regulation.
- 4.5 Growing numbers of physiotherapy staff hold a physiotherapy qualification below degree level. We consider it desirable to make provision for the admission of members into the Associate category holders of recognised non-degree physiotherapy qualifications. This will enable us to build relations and support such members prior to them starting work or in gaps in their careers. If agreed, it would be for Council in the future to agree which qualifications to recognise for this purpose or to agree a process for accrediting qualifications.
- 4.6 We are also recommending that Council approves a new grade within the category for career break associates. It is an anomaly that whilst Members who are on maternity leave can be offered a discounted membership grade, associates in a similar circumstance cannot. If agreed, it will be for Council to agree the fee at a later date.

4.7 Risks and Benefits

5. **Affiliate membership**

- 5.1 Our Bye-laws include a category of “Affiliated members”. As currently described, this is for students on non-accredited courses and overseas qualified physiotherapists. There are no non-recognised UK courses currently. Overseas qualified physiotherapists working in the UK or Crown Dependencies are admitted in other membership grades. As a result, we have no affiliate members.
- 5.2 The management of physiotherapy is often not in the hands of physiotherapists. In research, education, public and private practice physiotherapy involves working collaboratively with a range of other professionals who contribute to our professional knowledge or service delivery. As we are the Chartered Society of Physiotherapy, not the Chartered Society for Physiotherapists, we believe that this category should be reshaped to accommodate members who have a professional affiliation to physiotherapy, but who are not eligible for membership in another category.
- 5.3 Animal physiotherapy is a rapidly expanding area. There are two main routes into this area of practice. Chartered physiotherapists may practise on animals and veterinary clinicians may learn physiotherapy techniques to practice on animals. There are important discussions ongoing between our animal network, the Royal College of Veterinary Surgeons and DEFRA to establish a register of animal physiotherapists. This would create a system for vetting animal physiotherapists and could, if Council were so minded, enable us to recruit registered animal physiotherapists as affiliate members.

5.4 We are, however, mindful of the potential for dilution of the profession and for confusing the public if people who are not studying or practising physiotherapy are admitted into membership. It is for this reason that we favour a distinct affiliate category.

We noted that there will need to be a phased implementation of the revised category. This will enable the management of how quickly the category expands and the mix of members in it.

5.5 Proposals for subscription rates for, and service offers to, different grades of members within the Affiliate category will need to be considered as part of the next budget round. A set of interim grades has therefore been suggested:

- Affiliate
- Animal physiotherapist
- Affiliate working in physiotherapy
- Overseas Affiliate
- Physiotherapy graduate.

5.6 Benefits and Risks

5.7 Governance rights – We suggest to Council that there are three options for the governance rights for a revised affiliate category:

- (a) Full rights to stand for and vote for Council and to participate at the AGM
- (b) No rights to stand for and vote for Council and to participate at the AGM
- (c) No initial rights to stand for and vote for Council and to participate at the AGM, but with a scheduled review of this in two years' time.

6. Other issues

6.1 Corporate membership - In light of the practice of some other professional bodies, and the potential threat of a trade body competitor emerging, we considered the potential of offering corporate or group membership. However, we do not feel this offers any significant advantages to the CSP or potential corporate members. We have suggested that further work be done to consider whether a Physiotherapy Alliance scheme, modelled on the Royal College of Midwives Maternity Alliance, might be beneficial.

6.2 Flexibility of operations – The regulations are highly prescriptive in terms of the services members should receive and the subscription and the payment systems we can use to collect subscriptions. This does not fit well with the desire to be flexible for the future. We therefore recommend that such clauses be amended.

6.3 Discounts – The current system includes a range of grades designed to enable discounts to be applied to subscriptions. We consider the existing discounts appropriate and believe that there should be an additional discount for career break associates. Given that Council can amend subscription rates each year we would like to see more flexible use of recruitment and retention discounts considered. In replacing the subscription IT system, it would be sensible for the staff to ensure that a new system has this operational flexibility.

6.4 Post-nominals - At present only Members, Fellows and distinguished service award recipients have CSP designated post-nominals. We believe that having specific post-nominals for more membership grades would have advantages. These include greater clarity for the public, avoidance of accidental misrepresentation of members as Members and marketing benefits. In particular, we feel that animal physiotherapists and associates should be properly recognised. We envisage that P&D would advise Council on appropriate post-nominals and that this would lead to a further proposal to amend the relevant Bye-Law at the 2018 or 2019 AGM.

6.5 In conducting the review we identified some issues which were outside our remit or which we determined should not be addressed through the review. We believe that Council should, however, be made aware of these issues, which are included as Annex F.

7. Implementation

- 7.1 If Council accepts the recommendations, they will not come into force immediately or as a single block. There are both governance and operational steps to take prior to implementation. AGM and Privy Council approval is needed for the Byelaw changes. Before the affiliate regulations can be implemented, there is a range of operational changes required including IT system changes, developing marketing plans and administrative process changes. Different changes will therefore need to be implemented at different times.
- 7.2 The Member, Associate and Student regulation changes would be introduced immediately following final Council approval, although they might not be fully reflected in recruitment material for up to a year.
- 7.3 The new Affiliate regulations, moving graduates who are not yet HCPC registered into the affiliate category, could be introduced immediately, provided an interim administrative process can be agreed pending the new membership system deployment.
- 7.4 The introduction of the Affiliate regulations 1(i)-1(iv) will need to be phased over a longer time to enable IT and marketing developments.

8. Recommendations

8.1 Members

1. To agree to recommend to the AGM the byelaw changes, and to agree the revised regulations, relating to Members set out in Annex B.
2. To agree the creation of an animal practise grade within the Membership category for physiotherapists qualified to treat humans but who work solely with animals.

8.2 Students

3. To agree that membership between student member and either Member or affiliate membership should be continuous.
4. To agree to recommend to the AGM the byelaw changes, and to approve the regulation amendments, relating to student members set out in Annex D.

8.3 Associates

5. To decide whether to adopt the proposed new Associate regulation 4.ix affirming the voting rights of Associates on all issues at the AGM.
6. To agree to recommend to the AGM the byelaw changes, and to approve the revised regulations, relating to Associate members set out in Annex C.
7. To agree to introduce an Associate career break discount grade of subscription from January 2018.

8.4 Affiliates

8. To agree to repurpose the Affiliate category and to recommend to the AGM the byelaw changes set out in Annex E.
9. To agree the inclusion of anyone who works in, or manages, a physiotherapy service or business, in the proposed regulation set out in Annex E at 1(iii)
10. To agree the inclusion of regulated clinicians working in rehabilitation, MSK disorders, exercise or sports medicine or allied fields in the proposed regulation set out in Annex E at 1(iv)
11. To agree the inclusion of researchers working in rehabilitation, biomechanics, MSK disorders, exercise, sports medicine, sports science or allied fields in the proposed regulation set out in Annex E at 1(iv)
12. To agree the inclusion of researchers working in rehabilitation, biomechanics, MSK disorders, exercise, sports medicine, sports science or allied fields in the proposed regulation set out in Annex E at 1(iv)
13. To agree the inclusion of technical staff working in rehabilitation, biomechanics, sports science or allied fields in the proposed regulation set out in Annex E at 1(iv)
14. To agree the inclusion of sports therapists in the proposed regulation set out in Annex E at 1(iv)
15. To agree the inclusion of massage therapists in the proposed regulation set out in Annex E at 1(iv)
16. To agree the inclusion of physiotherapists and student physiotherapist who work or studies outside the UK in the proposed regulation set out in Annex E at 1(v)
17. To agree the inclusion of people studying on a non-accredited physiotherapy course, planning to study physiotherapy in the UK or who is studying physiotherapy in the UK on a course which is not accredited by the CSP in the proposed regulation set out in Annex E at 1(vi)
18. To agree the inclusion of former student members pending HCPC registration in the proposed regulation set out in Annex E at 1(vii)
19. To agree one of the following sets of governance rights for Affiliates:
 - (a) Full rights to stand for and vote for Council and to participate at the AGM
 - (b) No rights to stand for and vote for Council and to participate at the AGM
 - (c) No initial rights to stand for and vote for Council and to participate at the AGM, but with a scheduled review of this in two years' time.
20. To agree the remaining draft regulations as set out in Annex E.

21. To agree to have the following grades of affiliates for subscription and service management purposes:

- Affiliate
- Affiliate (working in physiotherapy)
- Animal Physiotherapist
- Overseas Affiliate
- Physiotherapy graduate.

8.5 Other

22. To request further work by staff to develop suitable post-nominal for consideration by Council.

23. To note the implementation advice set out in Section 7 of this report and to delegate to the Chair for Council the agreement of the implementation dates where not specifically identified.

ANNEX A - MEMBERSHIP REVIEW SLWG TERMS OF REFERENCE

The review will consider proposals for changes to the membership categories and make recommendations to Council for any changes considered desirable. In particular, it should consider:

- The potential benefits of a simpler membership system and a limited core membership benefits service, with additional benefits dependent on status and/or additional payments
- The potential benefits of a membership system based on progressive enhancement of status, and fees, as members move through their careers.
- The potential to broaden membership eligibility for individuals connected to physiotherapy including but not limited to; overseas physiotherapists, animal physiotherapists, managers of physiotherapy services, potential students pre-study, current associate members moving into new roles and sports therapists.
- The potential for membership or affiliation for corporate bodies connected to physiotherapy.
- Potential actions to address existing anomalies not covered above.

In considering these issues, the review should be mindful of:

- The desirability of maintaining a cohesive professional physiotherapy community
- The operational benefits or challenges of any changes
- The potential financial risks and benefits of any changes.

AFFILIATED MEMBER REGULATIONS (*proposed*)

1. Preliminary

- 1.1 These regulations are made by the Council of the Chartered Society of Physiotherapy (CSP) in accordance with the powers set out in Bye-Law 3(10).
- 1.2 In these regulations the term ‘Affiliated member’ or ‘affiliate’, indicates a person admitted to the membership of the Society who is not eligible to become; a Member, Associate member or Student member, but who meets one or more of the following criteria:
 - (a) is included on a register of veterinary or animal physiotherapists recognised by the CSP;
 - (b) works in, owns, or manages a physiotherapy service or business;
 - (c) works in a field associated with physiotherapy including:
 - (i) regulated clinicians working in rehabilitation, MSK disorders, sports medicine or allied fields;
 - (ii) researchers working in rehabilitation, biomechanics, MSK disorders, exercise, sports medicine, sports science or allied fields;
 - (iii) technical staff working in rehabilitation, biomechanics, sports science or allied fields;
 - (iv) sports therapists; and
 - (v) massage therapists.
 - (d) is a physiotherapist or student physiotherapist who works or studies outside the UK or Crown Dependencies;
 - (e) is studying physiotherapy on a non-recognised course or is, planning to study physiotherapy in the UK or Crown Dependencies
 - (f) is a student of a subject directly relating to a profession covered in 1.2 (b) – (d) inclusive;
 - (g) is an Honorary Fellow of the Society;
 - or
 - (h) is a former CSP Student member pending their HCPC registration.

2. Admission

2.1 Affiliated membership of the Society is at the discretion of the Council acting in accordance with the Bye-Laws in force from time to time. (Bye-Law 3).

2.2 Affiliated members may be divided into such grades as Council may see fit in order to assist with the effective provision of services or collection of subscriptions.

3. Subscriptions

- 3.1 Affiliated members shall pay such registration fees and/or subscriptions as may be determined by the Council in accordance with Bye-Laws 8(3)-(5).

3.2 Affiliated members whose privileges are suspended under Bye-Law 8(5) shall not be entitled to any of the rights and privileges conferred by these Regulations.

3.3 Affiliated members shall be removed from membership in the circumstances set out in Bye-Law 6(3) and (5).

4. Rights and privileges of membership

4.1 Subscribing Affiliated members shall be entitled to:

- (a) attend regional network and branch meetings;
- (b) vote for, or stand for election as, CSP Stewards and Safety Representatives;
- (c) attend the CSP Annual Representative Conference;
- (d) elect voting representatives to, or be elected as a representative to, the CSP Annual Representative Conference;
- (e) vote in industrial action ballots and consultative ballots where relevant;
- (f) use such services as the Society may deem appropriate.

Note one of these options to be adopted:

- (g) To stand for and vote for Council and to participate at and vote the AGM

Subscribing Affiliated members shall NOT be entitled to:

- (g) Stand for and vote for Council or to participate at the AGM

Subscribing Affiliated members shall NOT, pending a review in 2019, be entitled to:

- (g) Stand for and vote for Council or to participate at the AGM.

5. Duties and conduct

5.1 Affiliated members shall comply with a code of conduct which may be approved by Council from time to time.

5.2 Breaches of this code shall constitute failure to observe the Charter and Bye-Laws.

ANNEX F

Issues included for the information of Council

Early career physiotherapists – In reviewing the member journey for Members the SLWG felt there was a lack of specialist support and services for members in the earlier part of their careers.

Professional progression - In reviewing the member journey for Members the SLWG recognised that professional progression is not directly dependent on moving through different membership categories or grades. It has not therefore formed part of the redesign of the membership system, however they feel there is merit in developing a more structured system of professional progression that encourages members to develop their knowledge throughout a career and so that experience and expertise is formally recognised.

Pre-retirement physiotherapists - In reviewing the member journey for Members the SLWG felt there was a lack of specialist support and services for members planning their retirement.
